

NCS Avocats S.à r.l. operating under the name "NATHAN & CONDROTTE" is a limited liability company incorporated under Luxembourg law with its registered office at 16, rue Michel Rodange, L-2430 Luxembourg, registered in the Luxembourg Business Registers under number B225706. Its partners and associates are admitted to the Luxembourg Bar.

### Management of the files

The files are exclusively entrusted to the Firm, which is the only entity designated to be in charge of these files and which ensures their follow-up. The firm undertakes to provide the best service and to execute it with diligence. The Firm advises and suggests the useful and necessary actions to be taken in order to preserve the interests of the Clients.

The Firm is free to appoint the partner and/or associate in charge of the case and may call upon external lawyers under its own responsibility.

The Firm is free to appoint bailiffs on behalf of the client and, after consultation with the client, to appoint any other third party whose assistance may be necessary. In no case may this choice entail the Firm's liability, while the client is the sole contracting party and debtor of these third parties.

### <u>Fees</u>

In the absence of a specific agreement between the firm and the client, the fees will be calculated according to the usual criteria such as the time spent on the case, the importance of the issue at stake, the complexity of the case and its outcome.

The firm's invoices are immediately payable. Unless otherwise agreed, advance payments may be required. The firm may, depending on the case, fix a fee for the result.

### **Archiving**

Unless otherwise agreed, the firm is responsible for archiving the entire file for a period of five years after its closure. It is also possible for the client to have a copy of all or part of the file in return for payment (depending on the volume of the file) during this five-year period. At the end of this period, the file can be completely destroyed, unless the client requests otherwise.

## Liability

The firm's liability shall in no case exceed the maximum amount of the professional liability insurance. If the insurance could not be activated, the amount of the indemnity shall not exceed 15,000 euros.

# **Confidentiality/AML**

The information provided by the Client to the Law Firm is subject to the lawyer's professional secrecy. However, the Client is informed that, in accordance with the law of 12 November 2004 on the prevention of money laundering and terrorist financing, the Firm is obliged to disclose any transaction suspected of being linked to money laundering and terrorist financing (unless the Firm is in charge of a dispute).

#### **Intellectual property**

#### Jurisdiction and applicable law

The contractual relationship between the firm and the client is governed by Luxembourg law. The Luxembourg courts shall have exclusive jurisdiction for any dispute arising from or in connection with this contract, with the exception of the jurisdictions of the Luxembourg Bar in disciplinary or deontological matters or fee disputes.
